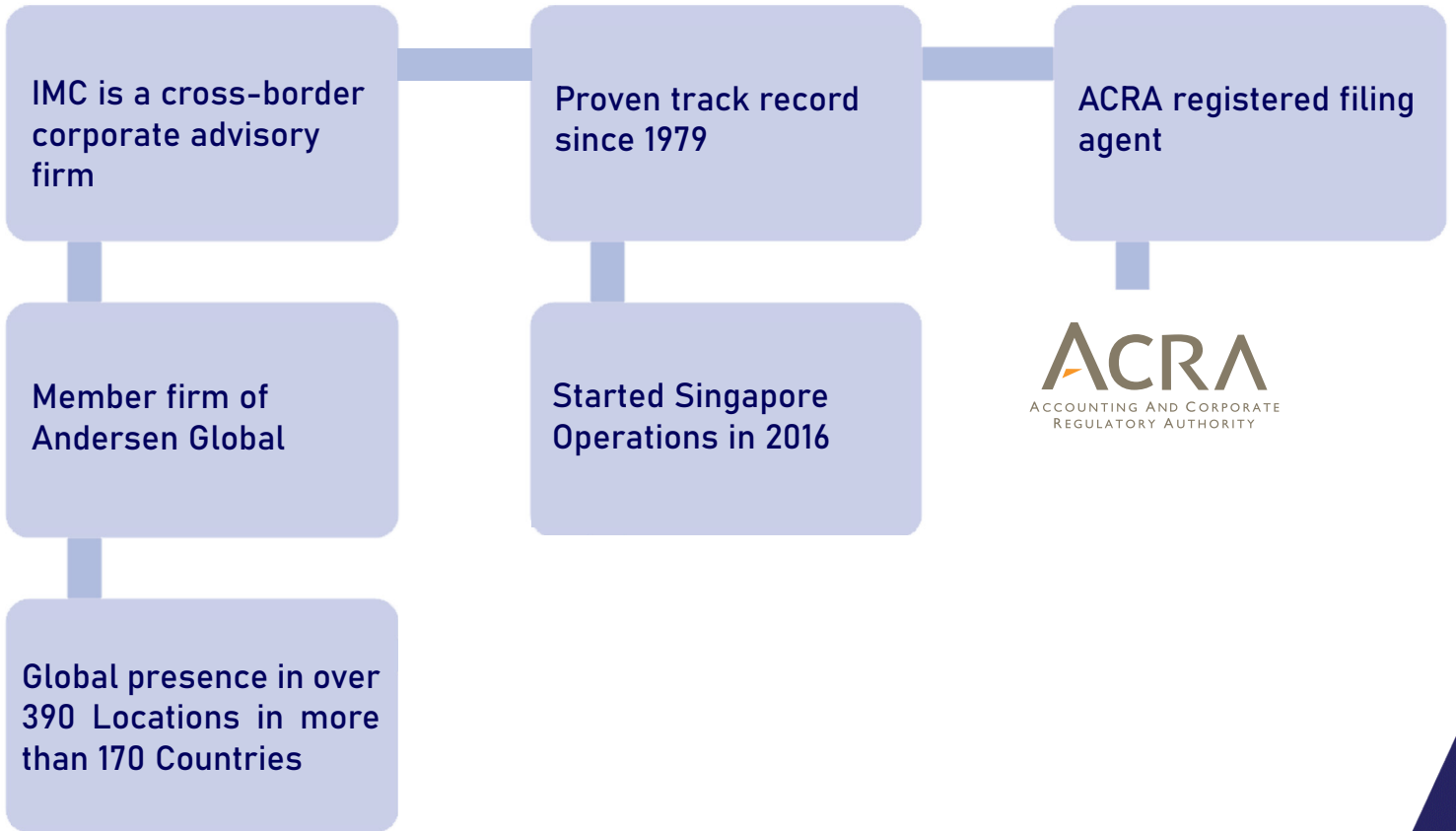

LIMITED COMPANY

Broadly there are 3 types of companies in Singapore:

- ▶ **Private Limited Company** which do not have more than 50 corporate or individual shareholders and exempt Private Limited Company which do not have more than 20 individual shareholder.
- ▶ **Public Company Limited by Shares** – It can raise capital by offering shares or debentures to the public and the number of shareholders can be more than 50.
- ▶ **Public Company Limited by Guarantee** – the company that carries out non-profit making activities that have some basis of national or public interest, such as promoting arts, charity etc.

(One local resident director, company secretary and registered office address is mandatory for all above three entity)
